1. Introduction

2. Information Collection

To provide you with our tailored services, we need to collect and process the following information:

3. Purpose of Information Processing

- Performance of a contract (Article 6(1)(b)) - Processing is lawful if it is necessary for the performance of a contract to which you are a party, or to take steps at your request before entering into a contract.
- Compliance with a legal obligation (Article 6(1)(c)) - Personal data can be processed if it is necessary for compliance with a legal obligation to which the data controller

is subject. This means that the processing is required for the controller to comply with the law.

5. Data Protection and Retention

Prospera Funding Limited will take all necessary steps to ensure that your information is treated securely and in accordance with applicable data protection laws. Your information will be retained only for as long as necessary to fulfil the purposes outlined above or as required by law.

6. Your Rights

Under GDPR, you have the following rights:

- The right to access – You have the right to request copies of your personal data.
- The right to rectification – You have the right to request correction of any information you believe is inaccurate.
- The right to erasure – You have the right to request the deletion of your personal data, under certain conditions.
- The right to restrict processing – You have the right to request restriction of processing of your personal data, under certain conditions.
- The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.
- The right to data portability – You have the right to request that we transfer the data we have collected to another organisation, or directly to you, under certain conditions.
